# Check-In

Various commission members shared how they have been talking to people who have experienced difficulties with engaging the city around specific community needs. There is a hope that RVAPB can help to mitigate and expedite those community needs in better ways. A specific example is the way in which traffic studies hamstring the ability to take action.

Erin shared that she had spoken with a Community Engagement Strategy in Williamsburg and how they are using community block parties as a means for more deeply engaging the community.

They also discussed their overarching role, which focuses on identifying contradictions between community need and what the city tends to focus on. How can RVAPB remedy this?

#### **Section Review**

#### Goals

The commission went through the goals that Erica had collected through their review process in November and December. They spent time considering how to translate values and goals. A focus in this work was setting an expectation for the community. It must acknowledge the past but also be thinking forwards. The is also a commitment to moving beyond buzzwords in order to build trust.

#### Timeline

#### Budget

The commission would like more information about the CIP budget and where investments have been made of the last few years. This will help to consider how to distribute the funds via participatory budgeting in a more equitable way.
